SUNDAY 26\11\95 8AM AT EAGLE VALE .

ON ARRIVAL I SPOTTED A COARSE FISHERMAN FISHING DOWN AT THE END UNDER DANNYS TREE, AFTER INTRODUCTIONS I FOUND HIS NAME WAS BILL CHILDS, AND AS YOU GUESSED, ANOTHER POMM.

AFTER INTRODUCING OUR CLUB AND RULES, PETER TURNED UP THEN REPEATED EVERYTHING ALMOST WORD FOR WORD AGAIN, TO WHICH BILL RELENTED AND JOINED ON THE SPOT. P.S. BILL IS THE PERSON THAT HAS CAUGHT A 42POUNDER AT EAGLE VALE IN THE LAST 6 MONTHS.

IN THE MEANTIME I GOT SETUP IN FRONT OF MY VAN WITH 30" OF WATER ON THE POLE LINE. FIFTHTEEN MINUTES LATER TEAM STEVE AND LIGHTNING DAVE FROM ENGLAND TURNED UP, SO BOTH AND PETER

I DECIDED TO SETUP MY LIGHEST GEAR FOR SOME PRACTICE, ON MY DRENNAN 13' LM.8 FLOAT ROD, 3LB SIGLON WITH MIDDY 2AAA BALSA STEPPED WAGGLER, WITH NO.16 CORN HOOK. DUE TO THE TREE AT 12MTRS I DECIDE TO GIVE A GO ON THE INSIDE LINE AT 9MTRS FOR SAFETY. WITH MY GROUNDBAIT WORKING REALLY WELL TODAY WITH HEMP OIL, I CONTINUED TO FISH BREAD PUNCH, EVEN ON SUCH A LARGE HOOK, AND LATER SWITCHING TO A SINGLE CORN WHEN THE PUNCH SLOWED DOWN. BY NOW I HAD 15 GOLDFISH AND 5 CARP, WHICH WAS A GOOD CATCH FOR THE DAY. AFTER SWITCHING TO CORN AND STILL CATCHING A DECIDED I WOULD BE HAPPY IF I CAN CATCH AS MANY CARP AS GOLDFISH. THREE HOURS LATER I HAD 17 GOLDFISH AND 20 CARP, ARE WHAT THE HELL, LETS MAKE IT 40. IN THE MEANTIME PETER AND FAMILY HAD LEFT, WITH STEVE AND DAVE LEAVING ABOUT 4.30. I WAS LEFT ALONE EXCEPT FOR ABOUT 8 OF THE LOCAL KIDS, WHICH WERE STILL TRYING TO CATCH THERE FIRST FISH FOR THE DAY WITH 20LB HAND LINES AND 2/0 HOOKS [BAD LUCK BOYS].

AFTER REACHING 40 AND THE FISH STILL ON, WHY NOT TRY TO CATCH 20 GOLDFISH FOR THE DAY. ON REACHING 45 [19 GOLDFISH-26 CARP] AND AS I WAS HAVING MY BEST DAYS FISHING SINCE JOINING THE CLUB, HEY WHY NOT GO FOR THE BIG FIVE O. JUST AS I MADE UP MY MIND THE KIDS AND THE FISH ALL TURNED UP TOGETHER AND REALLY INCREASED THE CATCH RATE. WELL THE LAST 5 TOOK ONLY 6 MINUTES FOR ME TO REACH THE BIG 50. TOTAL TODAY: 21 GOLDFISH / 29 CARP AT THE END BECAUSE I WAS CATCHING SO FAST AND RETURNING ALL THE FISH BACK TO THE WATER, IT WAS EXCITING ALL THE LOCAL KIDS, ASKING QUESTIONS LIKE:

MISTER, ARE YOU A PROFESSIONAL. MISTER, WHY DO YOU RETURN THE FISH. MISTER, HOW MANY HAVE YOU CAUGHT MISTER, WHAT BAIT ARE YOU USING ETC.

BY NOW IT WAS "SHITT" 6PM, SO I SAID, NOW THAT I HAVE HAD MY BEST DAY EVER, I WILL RETURN TO TRY MY LUCK ANOTHER WEEKEND. P.S. NO TURTLES OR EELS.

Memories of Canberra (10/01/96)

The reason why this article is called "memories" is that Stuart thinks Scott as supposed to do a match report as well as someone else. Who knows, so I thought I had better put pen to paper just to be on the safe side. As is usual for our Canberra trips it was only some of us who managed to make breakfast without the alcohol induced void between the ears or in Scotts case between the legs when he and his prepubescent mates missed out at the local knocking shops.

The day dawned misty quite cold and indeed it was difficult to see Stuart doing the pegging because of the reduced visibility. After the usual arguments over how many pegs should be in place the draw was made. On peg 19 it was difficult to see what was going on over the whole match stretch. Drawn between Dave Arnold Jr and harry (ACT visitor) who I had thrashed on day one of the nationals (Dave) and taught how to use a plummet two weeks previously (Harry), I thought I was in with a good chance. My main worry was Mr T drawn on the end peg 21 and the others up the other end.

Burley Griffin was flat calm although still dirty from the previous weeks rain when Dave (from UK) woke the ACT up with his screamed all in. On the pole at 11 metres I figured it would only be a matter of minutes before a fish graced the net wrong. Many hours of frustration and every method except the kitchen sink would by tried so while I was frustrating away others were doing better.

Dave Arnold Jr used the feeder all match under instructions from his Dad and managed a fish after about half an hour followed by others at all to regular intervals. Mr T was having better luck than me also managing a few fish as well. On peg 1 Matt hooked several fish but could not manage to land them (thankyou God) but at least he managed to stay on his box. Richard apparently could not resist the temptation and left his peg to help Matt by instructing him in the proper use of the landing net, it didn't work. Howard has told me several times since the match about his epic battle with an 8lb carp which he lost. Now if Howard is anything like me in terms of exaggeration this fish was probably no bigger than the average gambusia and would not have made any difference to the end result.

Back at my peg nothing was still happening when at about 8.30 the faint roar of a motor boat was heard. At about 9 several boats could be heard from the other side of the lake a few minutes later the first Tsuni large enough for a surfer to tube ride hit the bank apparently there were motor boat races on the lake. At about 10am the fog lifted, at about 10.30 the wind began and at about 10.35 there was so much debris in the water up against the bank that it would have been possible to walk the match stretch on it without getting wet.

At about 12 noon the dummy spit was on the cards as Mr T and Dave's boy were hammering me however Pete beat me to it muttering something about being ill he returned his fish (1) and went home. The one fish of the day weighted in at 2.12.08 and apart from being difficult to land because of the conditions did not put up much of a fight.

The end of the match saw me stirring up John Draper who was none to happy about my catch as he running second overall did not manage a bite on the day. Richard who either blanks or wins won with 27.06.08 followed by Ralph a few ounces behind. The Arnold's were third and fourth respectively with Ron coming in 5th with the only other double figure weight. On the day only 10 of the 21 participants scored which was disappointing given this venues ability to produce. No doubt there are some viable excuses such as alcohol, boats, wind, fog, debris etc although it would have been nice for Stuart to come up with something different for a change.

HI GUYS,

New years day and I havent woken up with a hangover so I have fought my way through the xmas tree and decorations to reveal my long lost desk and typewriter. We managed to get ourselves a white xmas which was great but are now paying the penalty for the festive season and the neccessary mixing with many people by duly catching a dose of flu, something we have managed to avoid since our return and my only new years resolution, (which was made weeks ago) has been broken at the moment I woke up. This was to go and pull out the biggest pike in the pit. This will now have to wait for a few days.

I resigned from the committee of the Rasen club before the agm in November and dragged Janet along to the main meeting of the year in an attempt to vote through a motion that would abolish the close season. I also had a trophy to pick up and was photographed with the MAYOR!....Fame at last!, The only thing was that the cup I won was the largest cup in the club and looks quite impressive but for some reason I was handed something more akin to an egg cup to display in the local newspaper whilst our secretary held up my cup for his photo, bit strange that, Still, the main thing was that when the vote was taken on the close season, we won the right to an extra three months fishing on the pit by.......2 votes, the power has gone to my head.

Girlfreind Stuart, Despite what you say, Ralph is not Gay and like he said when you two slept together in New Zealand and you branded him that way, quote" well how come it was MY bum that was sore"} anyway I digress, according to his girlfreind, Ralph was the best angler in Australia and no amount of talking was going to convince him to join a club. What did it for Ralph was sitting opposite me and desperately trying to winkle out one or two fish whilst my groundbaiting in the same place for a couple of months had the fish queing up to snaffle my bait. He couldnt help himself, And it was how do you do that?, why do you do that? etc etc etc, He was hooked really deeply and there was no way he was going to get off again. Since that day, I have never met another person with such a thirst for knowledge. If you want to beat Ralph in a match hes easy, just show him a small strange looking object before the whistle and tell him that its a secret weapon like the v1 or v2 and curiosity will kill the cat, He will be so mixed up in his mind trying to work out how this strange thing you have can help you win a match that he will miss every bite and only catch the fish that swallows his bait and jumps into his keepnet by itself.

Now then, John Draper,

This bloke was a bit of a worry from the start and standing face to face with him in the park I did my best to encourage him to put his name down. I liked this Kiwi from the moment I spoke to him and although it was obvious from the start that he was not a coarse angler, I thought he would be an asset to the club and make a good mate. When he turned around I thought How can a person be so wrong? and thought Id better try and put him off. Instead of taking out a couple of sections they drew as normal and I ended up with the nearest peg which was obviously the best peg and walked down to the waters edge to set up. Half an hour later, I was still on my own and could only see a load of small green mushrooms popping up on the other side of the lake {umbrellas} I spent most of this match walking a long way to my left and right to see what I had come to see, {other anglers } and had a few good chats despite my obvious dissapointment.

It was at this match that I met two future members, Stuart Deans and Mike Jones Stuart told me that he was moving up to Sydney, I told him I was starting a club up there and he begged me to let him be the club secretary. I said O.K. but for over a year after founding the S.C.A.C. non of our members knew what their secretary looked like.

A while after that and Stuart finally displayed himself and weve had nothing but trouble from him since. (keep up the good work mate)

Mike Jones lived in Newcastle at the time And also agreed to join the club. Before the club kicked off, I fished with mike on many occasions and found in him an extremely nice person

Battle to save poisoned creek

FIRE Brigade crews took control of the clean up of Toongabbie Creek yesterday where a chemical spill threatens aquatic life.

About 700,000 litres of water contaminated with the chemical Acronal has been pumped from the site, in Sydney's west, since Tuesday.

The Environment Protection Authority asked the Fire Brigade to take over while the EPA moved resources into trying to find what caused the spill.

Head of the EPA's western operations unit Steve Fermio said investigators would examine the Seven Hills premises of Australian Building Adhesives where the spill occurred.

About 50 firefighters and crews from Sydney Water used highcapacity tankers to pump the contaminated water from the creek and and built temporary dams to stabilise the flow of water.

Filters were in use further downstream to prevent further contamination.

About 25,000 litres of Acronol, used to make paint and adhesives,

leaked into the waterway after vandals damaged a storage tank. The EPA has separately begun a

crackdown on chemical industries. A complete ban on any new industries deemed to be potentially hazardous will be considered in waterside precincts.

There will be a safety review of all industrial plants near waterways throughout the State.

Industries identified as failing to comply with adequate safety and pollution control measures will face review of their licences.

Carp to be flushed out

A NATIONAL task force has been established to combat a fish despoiling Australia's freshwater rivers.

Scientists from around the country have begun an urgent search for an eradication program for the European carp which threatens the future of rivers around the country.

Task force member and NSW Fisheries senior scientist Dr John Harris said the fish were already well on the way to killing off several rivers around the State.

Introduced European carp already make up 40 per cent of all fish life in the entire Murray drainage area and in some areas of the river up to 80 per cent of the fish population.

The lower Lachlan River has also been seriously affected by the fish as well as parts of the Murrumbidgee, he said.

Dr Harris said the fish had also been linked with contributing to bluegreen algae blooms, killing off aquatic life in other rivers around the State.

"They really are one of the worst problems we have," Dr Harris said.

"They're extremely widespread in south-east Australia and it's becoming increasingly clear they are involved in environmental disruption."

Dr Harris said the carp were causing widespread destruction of the freshwater rivers through

their feeding habits which dirty the rivers and kill off aquatic life.

"They feed by taking in mouthfuls of the lake or river bed," he said.

"They gobble it up, sift through it, then eject whatever is inedible, muddying up the water."

Dr Harris said in eating up the river bed, the carp were disturbing small invertebrates and destroying aquatic plants essential to river life.

He said the fish had been associated with widespread destruction of aquatic plants as well as the toxic algae blooms affecting many inland rivers.

"In taking up the sediment from the bottom they are liberating nutrients which makes the nutrients available for blue green algae blooms," he said.

"An abundance of these nutrients is associated with the blue-green algae outbreaks."

The fish also burrow into river banks causing degradation of the river as well as threatening the survival of the red gums which line the shores of many inland rivers.

Dr Harris said native fish stocks around the State had slumped in areas where the carp was prevalent.

The task force would consider a range of options to eradicate carp.

Dear Bill,

In response to the article (Hooking anglers on law reviews) please find some thoughts stimulated by the item and by some of the problems faced by coarse anglers in NSW. It should be noted that the following listed ideas are not necessarily the views of the Sydney Coarse Angling Club Inc membership as the proposed review of Fisheries Laws has not been discussed at official committee or AGM level.

Preamble

As you know the history of coarse angling has its foundations in Europe especially the UK whereby game fish such as trout and salmon could not be caught and taken by persons other than land owners. The result of this, was the other fish (coarse species) were sought by anglers who legally were not allowed to pursue the better table quality fish. From this beginning the sport of coarse angling grew to an industry worth \$10 billion per annum in the UK alone (Anglers Mail UK). The sport of coarse angling over the years has developed into three separate areas ie. match angling, specimen angling and leisure angling.

Match angling is essentially a competition where a participant attempts to amass the largest weight of fish in a given time period. Annual world championships are held and in 1991 David Wesson (Australia) won the prestigious event in Ireland. Currently three of the SCAC Inc members have participated in the world championships, combined with this coarse angling is listed as a potential 2000 Olympic event and the SCAC Inc is the current holder of the national teams and individual titles.

Specimen angling is where a person attempts to catch the largest fish of a particular species usually using highly sophisticated rods, bite alarms and terminal tackle. Traditionally specimen anglers target species such as carp, barbel and catfish etc and travel abroad ie to France where the larger fish can be found. In Australia the use of coarse angling methods to capture species such as Murray Cod, Golden Perch etc have proved to be successful. The Australian tourism potential as a coarse fishing destination has not as yet been explored but no doubt would prove to be of interest to overseas anglers especially if it was known that large carp, eels and native fish were available. Further to this the staging of a world championship or inclusion of coarse angling in the Australian 2000 Olympics would cement coarse angling tourism in place.

Leisure angling is essentially just for fun but employs both match and specimen angling methods tactics and baits. The overriding ethic of coarse angling regardless of which methods are pursued is the safe return of all fish to the water regardless of species type and table quality.

Fisheries Law Review

Currently the Sydney Coarse Angling Club Inc officially conducts match, specimen and leisure day activities on a regular basis usually in the Sydney Metropolitan Area. The issues that directly affect the activities of the club and individual members are as follows:-

Match Angling

1. Prior to the commencement of a match several rods or poles are pre rigged so that an angler may change tactics during the competition, as fish species, feeding patterns, weather or water conditions change. Most club members will set up approximately four rigs usually consisting of match rods (2), pole (1), quiver tip (1), feeder rod (1) and whips. Currently restrictions in NSW only allow two rigged rods at any one time to be set up. Match rules (international as well as federal and club) allow the rigging of as many rods etc deemed to be required by the angler as long as only **one** rod with **one** hook is used at any **one** time. Rods not being used can not be pre baited.

Possible solution to issue - continuance of dispensation arrangements.

2. Size limits and bag limits imposed by current fisheries laws restrict match angling activities especially when Bass or potentially other native fish are being caught. On occasions several bass up to 2 and a half pounds or undersized fish are caught. If released immediately these excess or undersized fish may spook other species or a bass shoal potentially ruining an anglers chances of doing well in the competition or diminishing the anglers potential qualification to participate in national or international-events. Currently all fish caught in matches are landed using knotless landing nets and placed in large knotless keep-nets until the end of the match when they are weighed and returned to the water.

Possible solution to issue - continuance of dispensation arrangements.

Specimen Angling

1. Gear restrictions imposed ie the two rod rule currently affect both specimen and leisure angling activities. Through the use of sophisticated electronic bite alarms such as Optonic, Fox or Deakin equipment it is easy to use up to 3 rods in a fixed rod pod arrangement and at the same time use a float rod, pole, or whip to hand. In conjunction with the use of the alarms, bolt rigs and hair rigs for example prevent the gut hooking of fish. These methods have been specifically designed to catch large fish and at the same time maintain the fish in the same state of health as prior to it's capture. These rigs originally stemmed from carp angling however are also successful in the capture of Australian native fish.

Possible solution to issue - NSW Fisheries issue of multiple rod licences ie two rods per licence. (Compliance to be maintained by Fisheries). Therefore an angler can chose to purchase several licences within reason eg up to three.

Catch and kill sponsored events

The Sydney Coarse Angling Club Inc does not condone catch and kill angling events which usually target European Carp. On and educational issue, what are we teaching our children by staging such events on the premises that carp are destroyers of native habitat, native fish, or cause other problems frequently espoused by the angling media. There is very little scientific evidence that these fish cause undue problems in the freshwater environment, (see NSW Fisheries agfacts publications) other than not being a particularly good table quality species. The SCAC Inc are not carp lovers and do not condone the illegal stocking of these fish however as a sport fish they provide excellent value and to kill them because they are carp is an inappropriate action which does not teach our children the value of fisheries resources. These comments also apply equally to the taking of undersized fish or more than the bag limit for trout or native species.

Possible solution to issue - Education of media, fisheries inspectorate and public. Publication of the un-required killing of these fish.

Fish Stocking

As you know the SCAC Inc has stocked fish in several impoundment's in conjunction with Bankstown City Council ie Bass, Eel Tailed Catfish and Silver Perch. Several requests have been made relative to the stocking of other native fish such as Golden Perch, Macquarie Perch and Murray Cod which have been unsuccessful due to genetic considerations, or that the species are not native to the Sydney area. To achieve a greater bio-diversity and provide for improved match angling the SCAC Inc would like to see the stocking of non native fish such as Roach and Tench into impoundment's that are approved by NSW Fisheries ie above the 100 year flood level. The stocking of such fish would greatly improve the opportunity for the club members to compete successfully in Victoria or international events as these fish especially Roach are the main target species. Combined with this some stocking of these shoaling type fish may be required for Olympic or international events.

Access to Restricted Impoundment's

As you know the SCAC Inc has attempted to gain access to impoundment's such as Prospect Reservoir without success. It is unfortunate that in a large metropolitan city such as Sydney that fisheries of potentially superb quality are unavailable for use by responsible members of the angling community. It is respectfully suggested that NSW Fisheries continue it's push to allow recreational fishing at such impoundment's and on this issue the department would have the SCAC Inc's full support.

Conclusion

Coarse angling in Australia is a growing aspect of recreational fishing despite being inhibited by old paradigms or mind sets. In our own club and at Australian Federation of Coarse Anglers Inc level more Australians are joining the coarse angling circle. For those persons already using coarse angling methods it's appeal is the capture of fish using the lightest possible equipment, competition and continually improving methods employed, while the appeal of the sport to those new to it appears to be curiosity and the protection of fish species and the environment.

Coarse angling is no better than other methods of fishing such as fly or lure angling it is just different and arguments between anglers as to which method is better will always abound. The SCAC Inc does not want to inhibit other branches of angling nor does it wish to stop the taking of fish. However the SCAC Inc would like to see (as would interstate anglers) coarse angling being treated as a viable sport without being restricted by fisheries laws that in truth only apply because a baited hook is used. All fish are returned to the water, we wish to maintain or improve our aquatic environment, and develop and promote through education coarse angling methods and ethics.

Other issues that may arise during the course of the review such as closed seasons, licence fees etc can and no doubt will be discussed as they arise.

Dear Mr Scott,

I refer to your letter of 13 November 1995 regarding your Club's request to use the Sydney International Regatta (SIRC).

By way of background, the Olympic Co-ordination Authority (OCA) is responsible for the management of the SIRC, until all Olympic related activities have been completed, in early 2001. At present the SIRC is a construction site and will be so until March 1996, when the national rowing and canoe championships will be staged at the SIRC. The operational management of the SIRC will be established over the next few months.

In regard to your request, I do not believe that your Club will able to use the rowing\canoe course. The course is a purpose built rowing\canoe facility with stainless steel wire cables permanently installed for lanemarking buoys. These cables run the entire length of the course, 1 metre below the water surface level and at 13.5 metre spacings. I am sure you would agree that this setup would not be compatible with fishing, as fishing hooks would snag on the lanemarking wires.

However given the above, there may be some opportunity for your Club to use the rowing canoe course warmup lake, when the SIRC is not being used for rowing and canoeing regattas or training. This lake is connected to the course and will not have any lanemarking wires to worry about. The course and warmup lake will be the only publicly available water space, within the Penrith Lakes Scheme for the next 7-10 years.

When the SIRC General Manager is appointed, he\she will responsible for taking bookings at the SIRC from the sports and other users.

In the interim, if you would like to send me a list of the indicative dates that your Club may wish to use the SIRC warmup lake.



In recent summers many of our inland waters have taken on a pea soup appearance. The shoreline of lochs can look as though a turquoise coloured paint has been tipped along it. These so called scums are caused by dense aggregations of blue-green algae. Sarah Pritchard of the Clyde River **Purification Board** explains what it all means.



Blue green algae bane or boon?

What are blue - green algae?


The term 'blue-green algae', which was given to these microscopic organisms as a result of their classic blue-green colour, is in fact a misnomer. They are actually bacteria that exhibit some of the same properties as the true algae and are more correctly termed cyanobacteria. Their occurrence is worldwide ranging from arctic regions to the areas around hot springs where few other organisms survive. Most of us will know them as common constituents of our freshwater environments. They tend to be the dominant phytoplankton (microscopic floating plants) of lakes during the summer months when levels of nitrogen compounds, which are important plant nutrients, are at their lowest. Many blue- green algae are able to fix nitrogen and can therefore outcompete other algae. They thrive especially in warm and ealm conditions.


Generally speaking they proliferate in waters which are high in nutrients (eutrophic) and less abundant in waters which have low nutrient levels (oligotrophic).

The dangers

Our knowledge and awareness of blue-green algae has increased in recent years due to their tendency towards forming blooms and seums of a potentially toxic nature. Seums are formed as a result of the presence of gas vesicles in blue-green algae which make them buoyant thus allowing them to accumulate on the surface. If there is any current or wind, they are pushed towards the shore forming a seum. Events such as the deaths of sheep and dogs at Rutland Water. Leicestershire and illnesses suffered by young soldiers after contact with a dense bloom in Rudyard Lake. Staffordshire in 1989 led to great media attention and heightened awareness of the dangers.

The toxic nature of these blooms has been known for many years. However the first detailed account dates from 1878 documenting a bloom on the Murray River, Australia. It was noted that a blue-green alga had proliferated and formed a 'thick, scum-like green oil plant, some two to six inches thick and as thick and pasty as porridge'. This rendered the water 'unwholesome' for the animals that drink at the surface, bringing on a rapid and sometimes terrible death. Since then investigators have confirmed that many of the blue-green algae include poisonous strains.






Right: A common bluegreen algal species.

It has been found that blue-green algae contain many different types of toxins but most can be grouped into three categories: neurotoxins, hepatotoxins and lipopolysaccharides. Neurotoxins act in various ways on the nervous system of the body and can cause paralysis, respiratory arrest, muscular tremor, salivation, staggering and convulsions in animals which have ingested scum containing species that produce these toxins. Hepatotoxins have a major effect on the liver and have been implicated in the majority of incidents. Signs of poisoning in animals include weakness, vomiting, cold extremities, diarrhoea, heavy breathing and death due to pooling of blood in the liver where toxins have been shown to accumulate rapidly. They are also thought to be tumourpromoting. It is suspected that the high rates of liver cancer in some parts of china are tied to their drinking water originating from reservoirs that frequently suffer from blooms producing hepatoxins. Water treatment processes there only filter out the algae and dilute the toxins. In common with some bacteria such as salmonella, many blue-green algae produce lipopolysaccharides as normal components of their outer lavers. They are less toxic than that produced by salmonella but it is thought that they may be responsible or the skin irritation and gastrointestinal disorders observed in swimmers after contact with algal blooms.

It is important to note that not all bluegreen algae produce toxins and not all blooms prove to be toxic. It is in fact very difficult to ascertain whether a bloom is producing toxins. Not only is the procedure for isolating and identifying the toxins difficult but the toxicity of a bloom can vary greatly both temporally and spatially. The factors triggering the production of toxins are still poorly understood and toxins are released by cells depending on their physiological state. Evidence has shown however that blooms are more likely to produce toxins than not. It is therefore a wise precaution to assume that all blooms are potentially toxic.

The River Purification Boards of Scotland and the National Rivers Authority of England and Wales regularly monitor many of our reservoirs for the presence of bluegreen algae. When these are found to be abundant or if a scum is present, the relevant environmental health department and the people responsible for the water body are informed. They usually erect warning notices around the shoreline of the affected water. In lochs or lakes with recreational facilities this may lead to the suspension of some or all of the activities until the risk has passed, and this could be a matter of days or weeks.

Why the toxins are produced is again poorly understood and we can only speculate on the purposes they serve. They may offer some defence against attack by other organisms or grazers such as zooplankton (minute animals that feed on algae). It is indeed the case that these animals do not feed on bluegreen algae unless there is no other food around. It is also possible that the protective effect is incidental and that the toxins serve some critical function.

Why do blooms occur and what can be done about them ?

The occurrence of blue-green algal blooms is no recent phenomenon in the UK. The first authentic description of a scum on Langorse lake. Powys, dates from the twelfth century and in parts of the Midlands, scum formation was sufficiently common to have ominous and portentous significance in local folklore. However the number and severity of blooms in recent years has increased in many areas. This is generally attributed to the increasing amount of plant nutrients being discharged to our inland waters from agricultural, industrial and domestic processes, although many other factors are also important in bloom and scum development. There are many methods available for the control of blue-green algae. These include nutrient control, algicides, biological controls and physical removal.

Many are expensive and difficult to implement. The use of algicides is not recommended as it can cause a massive release of toxins as the cells die. A solution that has been increasingly used is that of barley straw. The exact way in which this works is still not fully understood. Bales of barley straw are distributed throughout the water body to be treated. As it decomposes it is thought to release a substance which controls algal growth. There have, however been varying degrees of success and a disadvantage is that this solution does not treat the underlying cause of algal blooms - only the symptoms. Nutrient control is the ideal long term measure but again is difficult to implement and even once measures have been taken it may be decades before real improvement is seen. This is because the plant nutrients will be accumulated in the sediments from which it will sooner or later be released.

The benefits

Finally a few words in the praise of bluegreen algae. Firstly they are ecologically very important in many regions and they are among the earliest known fossils which shows that blue-green algae already existed over three billion years ago. It is thought that they were the first organisms able to carry out photosynthesis and as such played an important role in the oxygenation of the air.

Research into the structure and activities


of these toxins is creating much interest in the medical world. They and their derivatives are being considered for use in the treatment of Alzheimers disease and may even help in the fight against tumour cells and the human immunodeficiency virus, the cause of AIDS.


As a result of their ability to fix gaseous nitrogen, they fertilise agricultural land throughout the world; an example is rice paddies where they are often added to the soil. They are now being claimed as nutritional supplements and *Spirulina* products have been available in health shops for many years.

In conclusion, although their ability to harm both animals and humans is undeniable, through ongoing research the benefits that we gain may prove to be greater.

The 1996 Trans-Tasman

(Steve Scott is sitting in my office and he has insisted that I print this although I have not checked it through properly, sorry if it reads badly blame Steve)

This year the competition is to be held in Auckland, apparently each year they swap countries ie Auckland this year Victoria next year and so on. Although I haven't left yet and I'm actually writing this part of the story from my office at work, I thought an introduction to international fishing trips was warranted for all those who feel inspired to compete in future events.

Howard decided to join us in N.Z., Teresa rang the travel agency to book him on the same flight as us. We subsequently found out that our 11.30am flight had been cancelled and that we had been moved onto a 2.40pm flight instead, Teresa told the agent to book Howard onto that flight as well. A couple of weeks before the flight we were informed that the 11.30am flight was back on and we had been moved back.

All seemed to be going well until the day before the flight. Howard popped into work to pick up his Team Australia Track Suite, during his time with me he asked what time I was getting to the Airport? I told him I would be there at around 9.30am, he said "WHAT! the flight doesn't leave til 2.30pm" (shit I thought, something's wrong here) A quick phone call to the Old bag confirmed that he was still on the afternoon flight although we were back on the morning flight. I apologised to Howard about the stuff up and told him I'd see him in New Zealand.

I've been in close contact with Stuart who, Stupidly in my opinion, has agreed to organise the NSW contingent's logistics. I feel this job could of been easier if some people (Ralph) took on some of the responsibility for their trip themselves. Apparently a certain party is on holiday and has left everything to Stuart to organise on his behalf. Unfortunately for this certain party who shall remain nameless (Ralph), Stuart can't organise him a place to stay for a couple of nights of his trip. This person (Ralph) has not left a forwarding contact number with anyone, so when the offer of cheap motel accommodation was offered Stuart couldn't accept it on his behalf. This anonymous person (Ralph) will be lucky if he doesn't have to sleep on the streets for a couple of nights, still he's done that before I'm told and I'm sure Berlin is colder than Auckland (oups! nearly gave his identity away).

The only concern I have at this stage is the weight of my baggage. I've removed everything I felt was not required and my tackle is still 40 kg that doesn't include clothes or anything else. Luckily for me Teresa and Jay are coming with me so I can use up some of their allowance. For anyone who is unaware baggage allowances (economy) is 20 kg per person, although they will normally allow up to 10kg over that. which means officially I have 20 kg remaining to get three peoples clothes into or unofficially 50 kg. As it turned out I managed to get it all in and the clothes and it all weighed 78kg, if you didn't count the hand luggage (which was packed with the heavy stuff).

We arrived on the Saturday picked up the hire car and took a leisurely drive North to Auckland. We got lost a few times but that was only to be expected. We were staying at The Best Western Accopulco in Ponsonby, which is about a 3 minute drive to Auckland city centre. I rang Danny when we'd booked in and he said he would pop in to see us on his way to the Airport to pick up Mike Williams. When he arrived we made arrangements for the match the following day at Houghton's. Houghton's was one of the venues for the Trans-Tasman competition the following weekend so a preview was most welcome. Howard was supposed to arrive about 8 o clock that evening but I received a phone call from him saying that he was in Melbourne and wouldn't arrive until 10.30pm N.Z. time (2 Hours in front of our time). This meant that Howard wouldn't arrive at his billet house until after Midnight. Howard asked me to try and contact his billet and apologies for the inconvenience and tell him he would be staying in a hotel that evening, I agreed to this and made a booking for him at the hotel we were in. I had a lot of trouble getting hold of Mel, (Howard's billet) but finally managed to get him on the phone at about 10pm only to find out the reason I couldn't reach him before was because he was at the Airport waiting for Howard.

Howard arrived at our hotel about midnight, I helped him to his room and told him Danny and Mike would be here to pick us up in 7 hours for the match. We said good night and I returned to my room.

We drove to Houghton's, Howard and I in one car and Danny and Mike leading the way in another. It takes about 45 minutes from the hotel through beautiful country side. Houghton's was absolutely stunning, what dreams are made of. We were welcomed by the New Zealanders and then the draw took place, I was pegged on the other side of the lake, which is a bloody long walk, but my swim looked brilliant I was pegged next to a lady named Bev who looked like she'd come from the same school of fishing as our own Johnny Draper, she was kitted out in thongs and was carrying a deck chair. Bev was a nice lady and we chatted a fair bit whilst I tried to figure out how to catch the Tench rather than the Rudd. Bev was catching Tench but at a slower rate than the Rudd I was catching. I finally managed to 'suss it' by bulking my shot about three inches from the hook, thus whizzing the bait through the shoal of Rudd and straight to the Tench. Although the Tench were slightly bigger, to about 1.5lb, they came much slower than the Rudd, I made a few adjustments to my rig, moving the bulk up and laying a couple of droppers onto the bottom. This technique was a happy medium, I caught the odd Tench but also a lot of Rudd this saw me catch every put in. with a couple of hours to go I put out the pole, this was not for any other reason than to experiment on methods. I realised that this was the only chance I would get to practice at the venue prior to the Trans-Tasman competition so I began trying a few things out. I was still catching every put in at the time of my change to pole but I needed to find a method that would work on the following weekend. I realised that the pole was not as affective as the waggler after about 45 minutes of trying different things, I even tried different rigs heavier, lighter, olivettes, no olivettes, bunched shot, spread out shot etc etc. It was about this time that I was distracted by two females to my left. They had turned up about half an hour into my pole fishing but I had only just notice that one of them had stripped completely naked and was laying face up. I mentioned this fact to Bev who retorted" I thought you were having trouble with your pole!" To add to this obvious kiwi ploy to put me off, the naked girl came right down to the waters edge and went for a swim, this was shortly followed by her climbing out of the water, pointing her bum towards me and laying face down to catch some more rays. Now I ask you hows a bloke supposed to concentrate on fishing when this sort of thing is happening?

Needless to say the hour and a half was a wash out, I had just a few more Rudd to add to my total and still hadn't sorted out a satisfactory method on the pole. When the scale finally arrived I was pleased to see that I had beaten most of the people to my left with a weight of 25lb, Bev had managed about 13 lb. When we got back to the cars and the final result presentation I found out that Mike Williams had come third overall and I had come 7th out of about twenty five anglers. I wasn't to disappointed considering that this was the first time I'd fished the place and the fact that if Fd kept on fishing the waggler I could've added a few pounds to my total.

Danny, Howard and Mike were driving down to the Mangowarra river the next day to fish a few days and try and find a method for the place, because I was with Teresa and Jay I told them that I would meet them there on Tuesday. After a day of sight seeing with the family, I got up at 4.30 am and made my way to the venue I arrived about 6am and there was no sign of the boys. I waited about an hour then decided to drive back to Huntley for a cup of coffee before returning to see if they had turned up. When I returned there was still no sign of them, I didn't want to set up because it was private property, part of a farm and you had to enter through gates to get to the river. I decided to wait, and wait and wait...... four and half hours I waited before I decided to give it away. I thought they had stood me up and decided to fish somewhere else for the day, I was spewing I drove the hour and a half drive backed to the hotel and spent the day sulking.

Wednesday was the last day we were allowed to fish the venue but I had made plans with the family to visit Rotorua that day. Rotorua is about a three an a half hour drive south but it passes through Huntley. I decided to drop in on the river just to see if anyone was there. And low and behold there they were plus a few new Zealanders and my old mate Reavis Stanley from Melbourne. Howard said "where were you yesterday?" I told him that not only did I come here but I waited in the car for 4.5 hours. I then found out the bastards arrived about fifteen minutes after I left. I was not a happy man. I walked the bank for ten minutes (kicking all their maggots into the river then left for Rotorua.

On Thursday night we met all the Australian contingent at a club in Auckland. We were then given all the information gathered by Danny Mike Howard and Reavis about the River and also Houghton's. It was quite an enjoyable meeting a few drinks and messing around. The Australian side was given a New Zealander, Barry, we were a man short on our side due to a couple of people pulling out through ill health.

Barry gave us a few pointers which was a great help. on the Saturday we all turned up at the Mangowarra river and the Australian were given some maggots and worms. Once the draw was made we all headed for our pegs. To help you visualise the river I would say it was about 20 metres across and wound it's way through a few fields, some of the pegs had a surface weed either side of the peg others like mine were barren. I must admit I wasn't feeling very confident when I got my peg, I had no features at all but the two New Zealanders either side both had weed to fish up against. Still I didn't let that put me off and decided to set up a pole a whip and a waggler. I started off ok with a few 1 pound fork tail catfish then after a couple of hours I was only catching small Rudd. The stamp of fish I was catching needed to improve to catch up with the two blokes either side of me. I didn't feed groundbait (as per our advice on Thursday night) despite the other team throwing a handful every now and again. I decided to mix up some white crumb in case things didn't improve. In went the crumb! and I started catch slightly larger Rudd but far to late to make a difference I was beaten both sides, I weighed 11.1 loz whilst Dexter to my left weighed 13lb plus and to my right 15lb ish.

I was done like a dinner! I came sixth in my section although this in itself was bad, the remaining Aussies did as bad meaning there was a 50 point deficit on the first day (which really meant that we had lost the hole thing on the first day) the second day at Houghton's was better but only marginally, I managed to get third in my section but this wasn't going to help the inevitable outcome NEW ZEALAND WINNERS again.
