
# Club Matches Scalesmen

This will carry on until the scales-men meet or the whole of the split stretch has been weighed in.

The last man weighed in will return the scales to the Match Secretary John Moses, along with the Net and Results board.

This will relieve the Match Secretary and anglers of the long wait.

We can all pack up earlier, and get home to the good old Roast and two veg, or socialize for a while. So lets all pull our weight {no pun intended} and help out.

Enjoy, **Brad.**Thanks for the article Ed.


#### **BEWARE OF TACKLE THIEVES**

# hot off the Press

Just in from Canberra, the good news that fisheries have accepted our rules and guidelines of coarse fishing to be added to the Fisheries Act for 2002.

This means that we will be allowed to fish as normal, as many rods made up as required with only one in the water at any time, the others can have hooks on them but not baited, the use of keep-nets for the retaining of fish for the duration of the match and we must return all the fish to the water with minimum harm.

All Native fish ie Murray Cod and Yellowbelly are to be returned straight back to the water, no weighing or retaining in the keep-nets.

All this allows Match fishing as we as Coarse Anglers are used to, to be incorporated in the new Fisheries Act, so that The Canberra Classic and any future Trans-Tasman Competitions will not be affected.

Also fisheries will be using Coarse angling Match rules in the act and the biggest bonus will be the Words Coarse Angling Mentioned in the New Act.

The committee have offered our assistance in any way with the new Fisheries rules.

So lets have a big round of applause and

# fish an tips YES! I CAN WALK ON WATER

Match report The Pound 2/9/01 The Epic Version

The day it all went according to plan!

Arriving first at the pound I was relieved to find no drug fuelled nutters parked in the car park but then Bill turned up, high on tea, so I locked my doors and thought about driving off. Fortunately Steve and Ron followed shortly after, so I started to relax and think about the pegging out.

5 pegs were placed on the DJs side of the bridge with the rest spreading most of the way up to the weir. Some lucky bastards other than me drew the money pegs. The pairs match a couple of weeks earlier had been fairly hard with not a great deal caught between the bridges. So when I drew the DJs end I was a bit puzzled as I had not fished there for ages and I was not really sure how to approach the session (I know how to talk the talk you know, too many hours reading Match Fishing). In the end I decided that I would concentrate maggots on the pole line and corn over towards the far side in a gap between 2 weed beds, but go fairly easy with the ground bait. Plenty of maggots in the ground bait but only a few grains of corn. I sounded the all in and went with a corn/maggot cocktail on the pole at 11.5 metres as the wind was forecast to strengthen later on. I did not want to get caught out having to fish the full length all day if the wind blew up. 11.5m would let me go out further if I could or come in a bit if it blew up and there were no significant shelves on the bottom anyway (they don't call me Son of Glen for nothing you know). I had really fancied Steves's end peg and fully expected him to start bagging as I had seen plenty of fish moving around up that end when pegging out. But as the saying goes, whilst you can only catch the fish that are in your swim you still need to be able to fish a bit to catch 'em! (Its called a joke Steve).

The first 1/2 hour saw a couple of funny old bites that took an age to develop and the strike brought nothing but a sucked maggot, lucky maggot. Changing over to a double maggot I got a good bite straight away of which I promptly missed. Next chuck saw me into a good fish, which I took my time over to get it in the net and at about 6lb it was a relief to get it in the net so early in the match. I could relax a bit. Now here comes the bit that will really piss you all off. I rebaited and shipped out, after a couple of minutes I thought a cuppa was in order so I shipped back the pole so I could turn round and get the thermos. When I looked back, the float which was suspended out of the water, started to shoot off. I pulled the pole backwards and was into another lump. This had taken a double maggot about 4 metres out in mid water. Now there's a bit of luck I thought as I slipped another 6 pounder in the net!

It was about this time that Norm who had obviously either been watching me in awe or had fallen asleep in his chair did a John Davis special and let his rod fly into the water with a fish on the other end. It shot out into the middle and Norm had to get his feeder rod out to snag it which he did without too much hassle. Laugh we did. The only problem is that I know I am going to do it one day and then everyone will be taking the piss out of me.

The rest was all a bit of a blur really. I scaled up to a 5lb bottom with a size 14 as all the fish seemed to be lumps. Double and triple maggots worked all day but it tailed off towards the end, not a touch on corn. Big fish, full of spawn most of them. I had a gallery behind me cheering me on most of the time, which was a real pain in the arse. {but he loved every moment of it ed} Every now and then I thought I felt beady, jealous eyes glaring at me from up Norm, Steve and Mark's way but I didn't look round as I was to busy catching lumps and signing autographs for my adoring fans.

I sounded the all out when I'd had enough of catching monster lumps and felt like going home but even I was a bit surprised when I went to get the net out of the water. I thought it was snagged on the bottom instead it turned out to be 42.42Kg of lovely stinking carp and a new venue record for the pound.

All in all, it was a cracking day for me at least. I don't remember what everyone else did and I didn't really care, as I was too busy being a smug bastard. { WHAT'S NEW ed} I was a bit pissed off I didn't take the club record weight or break the 100lb mark but there will always be Canberra.

## MERRYLANDS CENTRAL GARDENS FISHING CLINIC. 14/10/2001

After two lengthy meetings at Holroyd Council in preparation for this day and one wonderful days fishing trial apart from all the screaming kids and the Rain, it was in the school holidays! Howard and I arrived at 8.30am on Thursday 10<sup>th</sup> for a days trial

Top tips - Pole elastic.

There are many different types of elastics available. You can check the knot strengths and diameters of <u>Drennan and Kamasan elastic</u> in the tables below. You can also <u>check the sizes of Vespe elastic</u>. Other elastics may vary . The recommended line strength and dia. is based on <u>Drennan rig line</u>



**How do I set up my pole?** Shown below is a typical pole elastic set up. To set up your pole up you will need a <u>bung</u>, <u>Drennan</u>, <u>Kamasan</u> or <u>Vespe</u> elastic and an elastic connector. You will also need a <u>Drennan bush</u> or <u>Future bush</u> fitted to the end of your pole



### TYPICAL POLE SET UP

What length of elastic should I put in my pole? As a general rule when carp fishing I would put 6ft to 8ft of elastic in my pole. It all depends on the type of pole you use as the top sections of different models will vary in length. It is convenient to put the elastic through either the top section, top 2 or top 3. On most poles I would put elastic through the top 2 but some models have shorter sections and then it needs to go through the top 3. What you must remember is that the shorter the length of elastic you use the less distance a carp can run before the elastic comes under a lot of tension. When this happens quickly the hook can sometimes pull out. Alternatively if you use too much elastic it can be

difficult to control the carp properly and it can then take a long time to land the fish.

How often should I change my elastic? There are no hard and fast rules. it depends to a great extent upon how often you use it and how often you stretch it (i.e. how many big fish you are catching!) It is quite possible to leave thicker diameter elastics in a pole for two or three months if you are not using it regularly. If I was using the same elastics regularly and catching plenty of fish I would change it every three or four weeks. This is only a personal thing but if I am hoping to catch big fish I want to be sure that the elastic will not let me down. If you are not sure whether to change it or not check the end of the elastic where it comes out of the pole, this is usually the part that will wear first. If it looks ok then you can safely assume that the rest of it will be ok.

How tight should I have the elastic in my pole? It is usually best to have just enough tension in the elastic to ensure it all returns into the pole when a fish has just been landed. If some elastic hangs out the end of the pole it is a simple matter to shorten it slightly. There are occassions when the elastic needs to be slightly tighter. This normally occurs if you are fishing near any snags or features and need to apply more pressure to the fish immediately after hooking it to pull it safely away.

## Top tips - Setting up a feeder

There are many different ways to set up a feeder and every angler will have his own favourite methods and rigs. The feeder rigs shown below are a few of my favourites and are a good starting point if you are new to feeder fishing. The set up will depend what type of feeder you are using and also the type of venue and the species you are attempting to catch. These set ups can only ever be a general guide as it will often be neccessary to adjust the rig during a fishing session. It is quite common to change the hooklength on several occassions during the day in response to the way the fish are feeding. 
### 1. How should I set up my feeder?

Open end and cage feeders






Open end feeders

Open end and cage feeders can be set up in several ways. The simplest stillwater rigs are shown below -




The feeder is attached to the reel line with a clip swivel and a small loop is

then formed off of the the reel line between 4" and 8" from the feeder. The hooklength is simply tied to this loop with a half blood knot or a loop to loop method and you are ready to fish. This rig is suitable for still and slow flowing waters.

TYPICAL METHOD FEEDER RIG

Method feeders are set up in a totally different way to conventional feeders and can be devastating at times. They are designed for carp fishing and are popular with both carp and match anglers.

They are used in conjunction with a short hooklength and a heavy groundbait mix that will not break down quickly when in the water. Carp are attracted to the ball of groundbait and then see the hook bait lying 2" or 3" away. They usually cannot resist it. Bites are normally indicated by the carp trying to drag the rod into the water!

The information shown below indicates which feeder to use on a variety of venues. Nothing is definite in fishing and there may be times when feeders other than those suggested may work better.

**Bad news unfortunately** – Penrith Lakes Development Corporation has apparently denied access to the lake because we refuse to kill Carp. This is despite the fact that PLDC as well as site management wants us to use the venue and the provision of evidence supporting our argument. S Scott has escalated the issue to NSW Fisheries and K Flynn (site management) has escalated the issue to his senior executive.

S Scott submitted a letter to the committee for approval which is to be sent to the SIRC and PLDC requesting that PLDC reverse its apparent decision or provide in writing the rationale for not allowing the SCAC to us the venue. IF PLDC respond in the negative then it is the intention of the SCAC to escalate the situation to the Minister for Fisheries, Sport and Recreation etc to achieve our desire to use this venue.

On 14<sup>th</sup> of June S Scott was informed by phone by Ian Stainton CEO of PLDC that his team of experts had decided not to allow the SCAC to use the warm up lake given our ethic of releasing carp and goldfish etc. S Scott is awaiting a documented response from PLDC and once received it was agreed that S Scott will write to the Ministers for fisheries, sport and recreation and local member with a view of attaining their support re our desire to use the venue.

More bad news – it appears that the minister for fisheries does not want to support our cause. S Scott to draft a letter to the minister requesting a meeting to be scheduled with all interested parties.

**Some better news** - The minister for fisheries has agreed to the meeting. S Scott to draft a list of supporting evidence to be used during the meeting on the 31<sup>st</sup> October.

S Scott will seek legal advice prior to the meeting and inform the committee of the results. B Childs, J Moses & S Scott to attend the meeting
