## Match Report

Stewart at the far end also went well with just over 22lb. Right at the other end there was mostly misery. Steve vowed not to peg that side ever again, Robin was just glad that he had managed not to lose at least one fish at the net to grab a few precious points. But certainly even happier were Mark who could finally admit that he had won the title (but we already knew a couple of matches ago!!!) and Howard who with some late fish managed a section win, a third spot on the day and a comfortable second spot in the championship.

Great to see a new name on the winning list. And now the Pound for the last round to decide second and third spots in the ladder plus the Sections winner.

## Round 12 - Parramatta Pound

### 1 June 1997 - Match Report

Ohhhhh! The joys of being the match secretary!!!! You try to make things fairer for all, especially for the last match which still has a few spots to be decided, you try to make everybody happy and ..... and you end up displeasing a few. Considering what was at stake and having a quick count of who was there (always a last minute job since hardly anybody bothers to phone in before the match), it was decided to peg only on the side of the car park; this in theory is the side that fishes better so it made sense to have everybody there. But it also meant tighter pegs and of course a few people ended up counting the paces between pegs (it now seems that Steve makes very short paces) while some other shit-stirrer (I had to say that) even question what constituted the Pound. Of course the chance of catching a big fish and playing in the next peg was real, but it was so bloody cold that at least we could keep warm that way.

As it turned out, it was too cold even for the fish to venture into the shallow parts of the river. To make things worse Barry arrived late (as he had told me the night before) but no peg had been put aside for him. This meant either fishing virtually under the bridge or near the trees at the deeper end: a spot that was not pegged because, being much deeper, it was obviously better than the others. Fortunately Barry, being rather reasonable, accepted not to be included in the points for the match since he was not competing for anything, but just for fun.

The cold snap had affected the water a lot more than anybody imagined, with hardly anybody having a bite (probably the worse result overall at the Pound in quite a while). Things were going so bad that Ron, who before the match started was one of the most unimpressed with the minimum peg distance, later said: "I'll tell you what: I don't think it would have made any difference if you had f\*%&\* on pegged at FIFTY paces." (winner of the *statement of the year*!!!)

Predictably Barry had great fun with over 15 pounds; John Davis finally put his pole to the test for the best "official" weight and a deserved win. Steve in between shivers managed a fish which resurrected his championship grabbing a last minute third spot. While Howard, also with one solid fish, managed to clinch second spot overall AND to snare the *section championship*. Some people have ALL the luck while all the others blanked! Just joking of course.

Well, congratulation to all the winners but also to everybody who contributed to make this year a very competitive, challenging and successfull year.

**Ghost Carp (submitted S Scott)**

It was agreed that Ghost Carp will not be placed on the species list unless unless positive and clear scientific distinction can be made.

J. Alimeni has provided the solution to this issue in that ghosties are only a variety of common carp. However after much discussion the committee decided that subject to approval at AGM. that Black carp will be counted as Koi and any carp displaying white head markings and pale coloration will be counted as a Ghost Carp.

Agreed that Ghost Carp and Black Koi will be counted as species next year. J Draper dissented at this decision.

**Match results points deduction (submitted H Hill, S Scott)**

The current match rules allow for the worst three match results to be dropped from an anglers final championship score. In past years this has resulted in one angler losing the championship on two occasions, and this year one angler is in the position of having a choice of releasing fish unweighed and keeping points already scored, at the last match. Without going into to much detail it is suggested that this situation is ridiculous and should be changed. This will require anglers who don't fish all matches to release that if they want to be in contention they have to fish all events. Further to this, this years statistics indicate that anglers who only fish 9 matches or less don't figure in the championship race. Committee proposal either 11 from 12 or 12 from 12.

After much discussion, it was agreed that for next year 11 from 12 match results will count towards the championship.

**3:3/96-97**

**Identification of Goldfish / Crusian Carp (submitted S. Scott)**

A number of anglers have raised the issue of positive identification of these fish as an issue. There is a commonly held belief that Crusians were never stocked in Australia, however a recent article in a UK. magazine showed a long tailed fish which is caught on a regular basis at Lake Tuggranong (ACT) and Eaglevale, and identified it as a variety of Crusian. Positive identification is possible via fisheries if specimens are submitted to them. This requires the killing of the specimen, and is it appropriate given our catch and release ethic ?

D Kowalic to provide scientific identification data rather than killing a specimen at this stage.

At the SIRC it is required that nets are arranged away from the shoreline due to the shallow depth of water. Anglers have been fishing adjacent to there nets or simply wading out. Do we need a rule for this?

It was agreed by the committee that the following rule apply only to the SIRC as it is the only venue that requires any form of wading and commences immediately. Any angler may wade out to place a keep net in the water so that the nets rings are just submerged (for protection of fish) the angler may then fish adjacent to the keep net. Obviously this rule requires all anglers to show an appreciation of other anglers and has been implemented to avoid controversy rather than create problems.

? Should this be extended to other venues.

2 possibilities - 1 yes at discretion of match secretary. 2 - yes without restriction.

**DECISION by majority** wading only allowed at SIRC.

**5:2/96-97      Thunder ( electrical) Storms (Submitted S Scott)**

Given that it is possible for a match to be interrupted by a storm does the club require a rule. It was agreed that a rule should be implemented as follows.

- 1) more than half the match complete result stands as at time of storms beginning, or restarted following storm as long as the match is completed within the usual 5 hour time period i.e. 8am to 1pm.
- 2) Less than half of match complete match abandoned or restarted after storm as per 5 hour rule.

This rule will be invoked at the discretion of the match secretary following attention being drawn to the storm by another angler.

It was agreed that J Davis and D Kowalick are to look at SAS do's out side of the Sydney metro area. To be publicized.

**Ghost Carp (submitted S Scott)**

It was agreed that Ghost Carp will not be placed on the species list unless unless positive and clear scientific distinction can be made.

J. Alimeni has provided the solution to this issue in that ghosties are only a variety of common carp. However after much discussion the committee decided that subject to approval at AGM. that Black carp will be counted as Koi and any carp displaying white head markings and pale coloration will be counted as a Ghost Carp.

Agreed that Ghost Carp and Black Koi will be counted as species next year. J Draper dissented at this decision.

**1:3/96-97**

**Match results points deduction (submitted H Hill, S Scott)**

The current match rules allow for the worst three match results to be dropped from an anglers final championship score. In past years this has resulted in one angler losing the championship on two occasions, and this year one angler is in the position of having a choice of releasing fish unweighed and keeping points already scored, at the last match. Without going into too much detail it is suggested that this situation is ridiculous and should be changed. This will require anglers who don't fish all matches to release that if they want to be in contention they have to fish all events. Further to this, this years statistics indicate that anglers who only fish 9 matches or less don't figure in the championship race. Committee proposal either 11 from 12 or 12 from 12.

After much discussion, it was agreed that for next year 11 from 12 match results will count towards the championship.

**Identification of Goldfish / Crusian Carp (submitted S. Scott)**

A number of anglers have raised the issue of positive identification of these fish as an issue. There is a commonly held belief that Crusians were never stocked in Australia, however a recent article in a UK. magazine showed a long tailed fish which is caught on a regular basis at Lake Tuggranong (ACT) and Eaglevale, and identified it as a variety of Crusian. Positive identification is possible via fisheries if specimens are submitted to them. This requires the killing of the specimen, and is it appropriate given our catch and release ethic ?

D Kowalic to provide scientific identification data rather than killing a specimen at this stage.





Dear Mr Scott

Thank you for your letter of 16 April 1997, concerning the potential implications of a noxious species declaration for Carp.


Problems caused by Carp in freshwater systems are a focus of attention by my Department and considerable resources have been allocated to develop effective means to control this pest. This work has included research on the environmental effects of Carp and collaboration with other States and agencies to develop a national control program.

Research has documented the scope and severity of the problem and a national committee to co-ordinate the development and implementation of a Carp control program has been established. The emphasis for control will be on three levels; a national biological control program, work to restore river systems to help them resist Carp infestation, and the application of local control schemes in enclosed waterbodies.

The issue of declaring Carp a noxious species has been discussed within NSW Fisheries, but to date, has not been seen as an appropriate response to the problem. I appreciate your concerns in this regard, and thank you for your offer of participating with any proposed initiative. I will ensure that you are kept informed of any future proposal to declare Carp a noxious species.

Thank you for your invitation to attend a Sydney Coarse Angling Club fishing competition. I have heard a lot about the art of coarse fishing and would be interested to see it first hand. I am advised that your group will soon be applying for a permit for future competitions. I will examine the dates of these events and see if I can fit one into my schedule.


